

## Information Clause regarding the processing of personal data

According to Art. 13 (1) and (2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Regulation Data Protection) (Journal of Laws UE L119/1) [hereinafter: GDPR], informs that:

1. The **Administrator** of your personal data is **Daniel Rausz**, conducting his business under the trading name **GINGER'S TACTICAL GEAR**, with its registered office at ul. Gen. Bora-Komorowskiego 24, 80-377 Gdańsk,

2. Your personal data is processed **in order to distribute the newsletter to which you voluntarily consent** (art. 6(1)(a) of the GDPR), **and for analytical and statistical purposes which is based on the legitimate interest of the Administrator** (art. 6(1)(f) of the GDPR). Providing your personal data is voluntary, but a lack of this information will prevent the distribution of our newsletter.
3. Your data may be transferred to third parties for the newsletter distribution purposes, legal obligations by which the Administrator is bound, or to establish, investigate, or defend against claims. The entities to which your personal data can be transferred are accounting offices, law firms, online payment operators, courier companies, IT services providers, and institutions authorized to request them under the law (e.g. Police, Prosecutor's office, etc.) Your data is protected against unauthorised access by unauthorised persons by putting in place appropriate security measures.
4. **You have the right to:** access your data, request rectification or deletion of your data, request the restriction of processing, object to processing, and transfer of data. The implementation of such rights might be limited in some circumstances i.e. when the law requires us to keep your personal data.
5. With regard to personal data, for the processing of which you have consented voluntarily, you have the withdrawal right which you can exercise at any time, and this does not affect the lawfulness of the processing that was carried out before your consent was withdrawn.
6. You have the right to lodge a formal complaint to the President of the Personal Data Protection Office if you believe that the processing of your personal data violates the provisions of GDPR.
7. Your personal data will be processed as long as there is a legal basis for its processing, i.e. until your consent is withdrawn. The above-mentioned period may be extended if it is necessary to fulfill the legal obligation by which the Administrator is bound or if it is in the Administrator's legitimate interest (e.g. obligation imposed by law, protection, pursuing claims, etc.)
8.
